

**Consent
to the Processing of Personal Data
on the Website on the Internet**

I hereby decide to provide my personal data and, pursuant to Article 9 of Federal Law No. 152-FZ dated 27 July 2006 “On Personal Data”, give the Operator KMA.biz, for the purposes set out in the Operator’s Privacy Policy, my consent to the processing of the following personal data:

Processing of Users' personal data is carried out in accordance with Federal Law No. 152-FZ dated 27 July 2006 "On Personal Data".

The legal basis for processing personal data, the actions with personal data permitted by me, the terms and restrictions on their transfer and the processing period, and other conditions required by law for each purpose of personal data processing are defined by this Consent and the Operator's Privacy Policy, and I agree to these conditions.

I confirm that all data entered by me in the web form fields belongs to me personally and that, if I provide information about other persons, I confirm that I transfer their personal data to the Operator with the consent of such persons, pursuant to Part 8 of Article 9 and Item 5 of Part 1 of Article 6 of Federal Law No. 152-FZ dated 27 July 2006 "On Personal Data", as well as the receipt from any third parties of the User's personal data for the purpose of exercising legitimate interests and rights to provide services.

I express my consent that, for the purposes set out below, the Operator, in the manner established by the applicable legislation of the Russian Federation, has the right to entrust (delegate) the performance of certain actions with personal data to third parties, provided that they undertake to ensure the security of personal data during processing and to prevent disclosure of personal data. Such third parties are entitled to perform actions (operations) with my personal data similar to those that the Operator is entitled to perform.

I grant the Operator consent to transfer my personal data to third parties for the purpose of providing consulting and informational services (performance of agreements and contracts with the User).

I agree that the website collects and processes anonymized data about visitors (including "cookies") using web analytics services, as well as information about the browser, access time, information about the device used by the User to access the website, and the referrer (the address of the previous page).

Consent to the processing of personal data is specific, subject-focused, informed,

conscious, and unambiguous.

I confirm my consent to the transfer of information in electronic form (requests) (including personal data) via open communication channels of the Internet, including via messengers.

I agree that I shall be deemed to have given consent to the processing of my personal data entered in the form fields at the moment I place a mark in the checkbox (in the input field) on the Internet at: <https://kma.biz/> next to text such as: “I consent to the processing of my personal data in accordance with the privacy policy” or other similar wording, provided that, at each point of collection of personal data, the Data Subject is given the opportunity to review the full text of this Policy.

The purpose of personal data processing, the legal basis for personal data processing, the actions with personal data permitted by me, the terms and restrictions on their transfer and the processing period, and other conditions required by law for each purpose of personal data processing are defined by this Consent and the Operator’s Privacy Policy, and I agree to these conditions.

This shall be effective from the date of its signing until the date it is withdrawn in written/electronic form.

In the event of withdrawal of consent to the processing of personal data, the Operator is entitled to continue processing personal data without the consent of the personal data subject if there are grounds in accordance with Federal Law No. 152-FZ dated 27 July 2006 “On Personal Data”.
